INSTRUCTIONS FOR MAIL IN REGISTRATION FORM

Registration is required by your local Ordinance.

1. DO NOT fill out registration number or date on line 1.
2. Check dog, cat or specify animal being registered in "Other"
3. Place pets predominate breed. If pure, please state so. DO NOT put in "Mix" without having a breed to go with it. Example: Labrador Mix, Shepherd/Terrier Mix.
4. Predominate colors such as Black, Tan, or any combination.
5. Any distinctive markings or scars that would help identify your pet.
6. Place check mark for male or female and check mark for spay or neutered.
7. Your pets name.
8. Owners name, address, phone numbers (please list 3 if available) city & zip.
9. Your current email address.
10. Drivers license number, State of license, and owners Date of Birth are required!
Note: An owner must be an adult age 17 or older. Please do not list children as owners.
11. Provide legal signature.
12. DO NOT fill in the vaccination or fee information. You MUST include a copy of the Rabies Certificate issued by your veterinarian. Failure to include this document will result in your registration being returned. Please insure your pets vaccinations are current.
13. Please provide any special comments or medical information which may assist us in helping your pet in the event we cannot contact you. This may include medications, medical history, microchip information, or handling information.
14. If you would like information on any other services provided by the NTACA, please include a separate note.
15. Mail completed application form, copy of current Rabies Vaccination Certificate, and check or money to: (see fee structure below)

Current License fee structure for the City of Blue Ridge:

Unaltered (not spayed or neutered) dog or cat: \$20.00 Altered dog or cat: \$10.00

Fowl permit (per property): \$10.00 Livestock permit (per head): \$10.00

Exotic/Wild animal permit (each animal): \$250.00

Dangerous Dog permit (each animal): \$250.00

Late fee: \$20.00 plus cost of registration.
